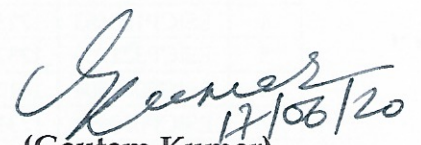

Important Note:

1. Candidates shortlisted for verification must **bring all the original documents alongwith two sets of self attested photocopies** of the following documents, in support of their eligibility criteria:
 - Print of online application form (PDF) and copy of Admit Card;
 - Certificate indicating Date of Birth;
 - All Educational/ Technical Qualification Certificates alongwith detailed Marksheet;
 - Professional Qualification Certificate alongwith detailed Marksheet;
 - Registration Certificate with the concerned Council wherever applicable;
 - Caste Certificate issued by appropriate authority (Candidates belonging to OBC category have to submit OBC certificate in the prescribed proforma of Govt. of India along with the form of Declaration, as per Annexure 'A' & 'B' annexed with the uploaded result);
 - Experience Certificate wherever required and as mentioned in the advertisement;
 - Disability Certificate in case of Persons with Disability (PWD);
 - Discharge Certificate in case of Ex-Serviceman;
 - Two recent passport size photograph;
 - "No objection Certificate" from the present employer, if the candidate is already employed in State / Central / PSU/ Autonomous Body. Candidates seeking age relaxation as Govt./ESIC employee shall have to produce Service Certificate;
 - Photocopy of valid Photo ID viz. Aadhar Card, Driving License, Voter ID Card, Passport etc;
 - Affidavit in case of mismatch in the candidates' name / father's name etc. on various documents subject to the satisfaction of Competent Authority;
2. Calling of candidates for documents verification does not confer any right upon candidate for his/her appointment to the concerned post. The candidature of candidates is purely provisional;
3. If, it is found at any later stage that any candidate has appeared through proxy or involved in malpractice his/her candidature will be cancelled and strict action, as per law, will be initiated;
4. Candidates have to make their own arrangement of stay and no TA/DA shall be admissible for the same;
5. Communication with regard to document verification will be sent to the candidates through their registered email ID only. If any candidate does not receive the same, he/she can appear for document verification, as per above instructions and schedule;
6. The candidates who are not willing to join ESIC may intimate the same through email (rd-gujrat@esic.nic.in) to avoid further correspondence.
